Important Reminders: Each calf must receive 2 rounds of shots to qualify for the sale

FOR 2023: All HEIFERS are REQUIRED to have a shot of Lutalyse or Synchsure on second working (Consult your Veterinarian for this product) **Administer IM per label Directions**

Follow all directions for proper handling of vaccines and follow this vaccination schedule:

Record name of vaccine used, along with lot number on bottle and date administered to be returned to Susan Parks by November 3, 2023. This form will be mailed to you with your tags. This program does not require that you have a veterinarian administer your vaccines or sign your health protocols, but you do need to keep accurate records regarding vaccines used and date administered.

In addition to shots, all calves must have TN Hereford Marketing Program ear tags, be de-wormed, must be dehorned \& healed or tipped to 2" or less. All male calves must be castrated and healed. Male calves not healed or still carrying scrotal sac will be sold as singles. Cattle must be weaned by September 30, 2023 for the November 15, 2023 sale.
